As part of our statutory audit work, we audited your Company's annual financial statements for the period ended 31 December 2025. Our audit was conducted in accordance with professional standards applicable in France, and was planned and performed solely for the purpose of issuing an opinion on the annual financial statements taken as a whole and not on any individual items of the accounts used to determine the total amount of remuneration paid to the Company's most highly paid people. Accordingly, our audit tests and samples were not made with this objective and we do not express any opinion on any components of the accounts taken individually.

We carried out our work in accordance with the professional standards of the French National Institute of Statutory Auditors (Compagnie Nationale des Commissaires aux Comptes). This work, which did not constitute an audit or limited review, consisted of making the necessary reconciliations between the total amount of remuneration paid to the Company's most highly paid people and the accounts from which the figure was calculated, and verifying that it was consistent with the information used to prepare the annual financial statements for the period ended 31 December 2025.

On the basis of our work, we have no comments to make on the consistency between the total amount of remuneration paid to the Company's most highly paid people as stated in the attached document and amounting to € 2 234 836,71 and the accounts used to prepare the annual company financial statements for the period ended 31 December 2025.
